

RE: PROPOSAL FOR 2013 NEW JERSEY RIGHT-TO-KNOW AND HAZARDOUS COMMUNICATION PROGRAM SURVEY

PARS Environmental, Inc. (PARS) is pleased to provide the Glassboro Board of Education (District) with this proposal for professional services regarding New Jersey Right to Know (RTK) and Public Employees Occupational Safety and Health (PEOSH) Hazard Communication Standard (HCS) compliance.

BACKGROUND

On November 13, 1995, Governor Whitman signed Bill S-7 which amended the requirements for the submission of the New Jersey RTK Survey. A complete RTK survey is required to be submitted every five (5) years, with survey updates to be completed between complete surveys. By July 15, 2014, the New Jersey Department of Health (NJDOH) requires that the 2014 RTK Full Survey be completed and delivered to the NJDOH, local fire, police, emergency planning committees, and county lead agencies. A copy of the full survey must also be maintained at the workplace.

SCOPE OF WORK

The scope of this project is to assist the District with their compliance efforts with the NJDOH RTK Program requirements.

TECHNICAL APPROACH

The technical approach to meeting the goals of the scope of work include:

- PARS will conduct a chemical inventory of each District building that houses chemicals. For the 2013 calendar year, the full survey will be completed for the high school, four annex buildings, middle school, and three elementary schools.
- PARS will input the data into the PARS CheMonitor™ based on the inventory.
- PARS will submit the 2013 RTK Full Survey, on behalf of the District, to the NJDOH
 and appropriate local agencies for each District facility. The District will be provided one
 copy of the full survey to be maintained at each facility, as well as a master copy to be
 maintained at a central District location.

ASSUMPTIONS

Inherent within the purpose and scope of work are several basic assumptions:

- The District will provide a RTK coordinator who will serve as the contact person for the
 District. This individual should be familiar with the location and use patterns of the
 chemical products at the District's facilities.
- The District representative will complete and sign the first page of the New Jersey RTK Full Survey.
- The District will conduct a "walkthrough" as required by the New Jersey RTK laws.
- The District will provide product Material Safety Data Sheets (MSDS) or Safety Data Sheets (SDS) for all new products identified from the 2013 RTK Full Survey.

SCHEDULE

PARS is prepared to initiate work on this project within one week upon receipt of your written approval. Upon acceptance of this proposal, PARS will schedule the field work to ensure completion and submission of all deliverables prior to the July 15, 2014 deadline.

PROJECT COST

PARS will provide the services described in the above Scope of Work in accordance with the attached Terms and Conditions. The cost to complete this project will be on a lump sum basis. PARS will complete this project for a lump sum cost of \$2,280.00.
