High School Plus/Career Technical Education (CTE) Program Agreement 2022-2023

Agreement between CAMDEN COUNTY COLLEGE and Glassboro High School

This Agreement is entered into by and between Camden County College ("CCC") and Glassboro High School (the "High School").

Through the **CCC High School Plus/CTE Program**, CCC agrees to provide instruction in degree credit courses to eligible high school students at a reduced tuition rate. This agreement reflects current policies and practices of Camden County College and permits students to earn college credits for courses taught during the school year at their high school.

Camden County College and the school district hereby agree to the following:

- 1. Camden County College and the high school district agree to establish a program to provide courses for college credit to selected high school students at the High School.
- 2. Only courses normally taken by Camden County College freshman may be made available. These courses shall be selected by the CCC academic dean from among those offered by Camden County College to regularly admitted students.
- 3. Participation in courses for college credit shall be limited to <u>high school college preparatory</u> <u>juniors and seniors who have superior academic records</u> and/or other students recommended by the principal.
- 4. The High School shall make adequate and appropriate library, laboratory and computer resources readily available to students at the High School.
- 5. The courses shall be taught by High School faculty members, who shall each nevertheless remain an employee of the High School and not CCC. Each participating High School faculty member designated by the High School shall have a minimum of a master's degree, or the equivalent, in the specific academic area to be taught. The High School curriculum and High School teacher must be approved by CCC's faculty liaison.
- 6. Camden County College shall offer, and High School faculty shall be required, to participate in an initial orientation and training program, and, thereafter, one or more annual training or evaluation seminars as determined by Camden County College.
- 7. Camden County College shall provide examination materials and specific criteria for grading by faculty to insure comparability of student performance. Camden County College will require, in these courses, no more and no less than is required in comparable college courses offered at CCC.

- 8. Camden County College syllabi and standard Camden County College texts or approved equivalents shall be used.
- 9. There shall be regularly scheduled visits by faculty and/or administration from Camden County College to evaluate the program, review examinations, student projects and reports, and to discuss any problems students or faculty might be experiencing.
- 10. Before enrolling, each student shall be given a written statement making clear that there is no obligation to attend Camden County College, and making clear that credits earned may not be acceptable at some institutions.
- 11. Students shall meet all of the following entrance requirements:
 - be in a college preparatory program and/or have principal's approval;
 - complete a registration and parent required statement form.
- 12. At the time of registration, students applying for college credit will be charged by CCC, a reduced registration fee for each course.
- 13. The high school agrees to report to Camden County College which colleges the graduates of these courses attend, the credits granted for the courses, the value of the program in the students' view, and other such appropriate information, as shall be specified from time to time.
- 14. Camden County College will reimburse the district an amount per student enrolled to defray the direct cost of instruction provided by the school district's teachers who teach the Camden County College courses within the school workday.
- 15. The High School shall report grades for all students to CCC at the completion of each course.
- 16. Both CCC and the High School shall maintain the confidentiality of all grades and other relevant student information in accordance with FERPA (Family Educational Rights and Privacy Act of 1974, 20 U.S.C. sec. 1232g, commonly known as the Buckley Amendment).

TERM OF AGREEMENT: This Agreement shall supersede all prior agreements and shall be deemed automatically renewed for succeeding academic years unless either party notifies the other party in writing of its intent to terminate this Agreement at the expiration of that academic year. It is understood and agreed that the parties to this Agreement may only modify or revise this Agreement by written amendment signed by both parties.



2021-2022 SCHOOL SERVICES DIVISION OF SCHOOL, COMMUNITY & WORKFORCE TRAINING PROGRAMS

Dear K-12 Partners:

Camden County College is proud of the invaluable connections we have with the communities we serve. Among the most important are the partnerships we have built with our K-12 stakeholders over the years. These partnerships not only provide academic and economic benefits to our local school districts, they greatly benefit the participating students. Over the past year, we experienced record participation in all of our high school programs.

I believe one our greatest accomplishments this year was assisting 104 high school students earn their high school diploma through our Gateway to College and Transition to College programs. Additionally, 18 high school students earned their Associate degree in Liberal Arts from Camden County College before graduating from high school. At our next commencement, we expect nearly 60 students to earn their Associate degree while still in high school.

Our most popular high school program continues to be our High School Plus/Dual Credit Program. In 2021/2022, we had over 6,000 student registrations submitted for this program; which was our largest participation to date. The support each of your school districts have shown to this program over the last five years has allowed it to grow nearly 200 percent. Due to this growth our most recent data from the National Clearinghouse shows that students with dual credit have enrolled in 239 college and universities throughout the country, in addition to Camden County College. Also, since students are now participating in the High School Plus/Dual Credit program over a 2 to 3-year period, a significant number of students are able to start college earlier than their peers.

In addition to the dual credit program, Camden County College continues to expand its Career Now program, which allows high school seniors to participate in evening technical certification programs through our Career and Technical Institute. In total, 44 students participated in Career Now last year and that number has nearly tripled this year with 117 students pursing certification in either cosmetology, electrical, plumbing, HVAC and a number of our other technical education courses.

We continue to offer our traditional College Now Campus Course program that allows high school students to take as little as one class to gain a feel for college, while a significant number of students spend their entire senior year at campuses in Blackwood, Camden and Cherry Hill.

For more information, I invite you to review the enclosed School Services Report which provides a list of additional resources the College provides to school districts in the region. Also included in the report is College data specifically pertaining to your high school. Finally, along with the report is a rebate check to cover a portion of your instructional costs incurred through the High School Plus Program last year. Camden County College is continuing to seek new community partnerships and opportunities for growth. I invite you to connect with us to share your ideas for new joint programs and resources for student success. Your continued input and cooperation will ensure that the next iteration of the College's strategic plan will better enable us to provide an affordable, accessible, and equitable education for the students we serve.

COLLEGE NOW

CAMPUS COURSES

High School students who qualify may enroll in college courses at any of the three Camden County College campuses and bank the credits for transfer at most colleges and universities. Courses may be taken during evening hours, weekends or during the day.

HIGH SCHOOL PLUS

One of the largest dual credit programs in the state which provides students college credit for college level work completed at their high school.

CAREER TECHNICAL EDUCATION

A program that provides students with the ability to earn college credits in a variety of technical fields.

COLLEGE EXPRESS

This program upgrades the academic skills of high school juniors and seniors in preparation for attendance at Camden County College. Students will also save tuition cost and also expedite their College readiness.

COLLEGE READINESS NOW GRANT

This program provides Camden County College High School students that are deemed not to be college ready with free developmental courses at Camden County College. The goal of the program is to have students become college-ready prior to graduating from high school.

PROFESSIONAL DEVELOPMENT

LECTURE SERIES, TEACHER WORKSHOPS, TEACHER EDUCATION

Teachers completing professional development activities at Camden County College receive a Certificate of Completion indicating course credit or College CEU's.

ADVANCED PLACEMENT SUMMER INSTITUTE

In partnership with College Board, CCC offers an Advanced Placement (AP) Summer Institute to provide high-quality professional development opportunities to AP and Pre-AP teachers.

ALTERNATE ROUTE TEACHER CERTIFICATION PROGRAM

This partnership with New Jersey City University offers New Pathways to Teaching in New Jersey, an alternate route teacher education program.

OUTREACH PROGRAMS

PROGRAM OUTREACH

Program outreach offers campus tours, information sessions, off-site high school visits, and off-site visits with local community agencies and businesses.

21ST CENTURY LEARNING COMMUNITIES

This program provides academic enrichment through after school programs.

OFF-CAMPUS COURSES

College credit courses offered at various high schools in the county.

CAREER PATHWAYS PROGRAM

This program offers educational opportunities that enable students to pursue higher education and/or gain entry-level skills in their career choice.

GATEWAY TO COLLEGE/TRANSITION TO COLLEGE

Camden County College's Gateway to College and *Transition to College Programs* are designed to address the needs of students at risk of withdrawing from high school, or have already withdrawn. Students completing either of these programs will receive a high school diploma from their sending school.
