- 1. Grievance for employee dental contributions for those electing the high deductible plan. A meeting with negotiations committee was requested to discuss a sidebar to resolve.
- 2. Discussion with their leadership resulted in an agreement to continue discussions on sports coaches and cocurricular advisor stipend proration. Solicitors recommendation was to revoke the proration language approved as new business at the July 29, 2020 special meeting.
