Starting with a March 1st date will allow the firm to start pulling data and creating a sandbox for stakeholders to utilize. Implementation date is targeted for July 1, 2021. Also included in the pricing is training and excellent customer service. **Details and ramifications:** The financial, HR and Payroll software in place has not been upgraded by the firm. The software has inherent issues and did prevent the business office from moving forward while trying to close out months. It also has communication issues with other database programs in district and is being housed internally on an aging server. Moving to this system will be less annually (Systems 3000 is costing the district \$30,714 annually) and allow for full integration with the NJ Smart reporting, Aesop and other databased programs. It is recommended that the district also purchase the cloud-based programming, bypassing the need for an internal server dedicated to the program. It also allows for an extra measure of cyber security and disaster recovery/back up retention as the program/data would be stored through AWS. Positives: The program will allow multiple programs to communicate. It also allows for ease of use, financial integrity, and cyber security. Technology department will have a lesser role in the running of the system.
