Mrs. Lipsett,

I will have the petition along with your daughters statement provided to the entire board of education, along with a copy of your email and my response. I truly appreciate the passion of the students along with the support and feedback of the community members present.

I regret your feelings regarding the BOE proceedings, but as the board president, I have the (often unfortunate) responsibility to follow district and state policy regarding personnel matters. I have attached the BOE policy regarding the situation in question. As you will see, the Board of Education cannot take action unless the Superintendent makes a recommendation or the employee requests a board hearing. Neither of these happened and as such, the Board cannot take any action.

I will be more than happy to meet with you to discuss the process further, but cannot discuss the employee due to confidential and personal reasons. You may also request a meeting with the superintendent if you desire.

Again, I am sorry that the perceptions of the meeting were negative, but it wasn't intended to be that way. I and the board listened intently and were sympathetic to the concerns. I was particularly impressed with the students, and didn't realize that all students didn't have opportunity to speak. Please extend by apologies to your daughter.

Unfortunately, state regulation (N.J.S.A 18A:27-4.1.), which mirror district policy prohibits action of the board without the recommendation of the superintendent or a requested hearing with the staff member.

I appreciate your feedback and hope the attached policy language provides you a better understanding of the process regarding these types of issues.
