RESOLUTION 2019-2020  
AUTHORIZING EXECUTIVE SESSION

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Glassboro Public Schools District will go into closed session for the following reason(s) as outlined in N.J.S.A.

10:4-12:

X \_\_\_\_\_ Any matter which, by express provision of Federal Law, State Statute or Rule of Court Shall be rendered confidential or excluded from discussion in public (Provision relied upon: \_\_\_\_\_);

\_\_\_\_\_ Any matter in which the release of information would impair a right to receive funds from the federal government.

X \_\_\_\_\_ Any matter the disclosure of which constitutes an unwarranted invasion of individual privacy;

X \_\_\_\_\_ Any collective bargaining agreement, or the terms and conditions of which are proposed for inclusion in any collective bargaining agreement, including the negotiation of terms and conditions with employees or representatives of employees of the public body (Specify contract: \_\_\_\_\_);

\_\_\_\_\_ Any matter involving the purpose, lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed;
