▲ While cost metrics are below the industry metric these costs are actually too low and indicate a disruption to acceptable service.

January 2022 YTD Food Cost was \$0.87 cents per meal. All districts have seen 10-15% increases in food cost, Glassboro is \$0.21 cents less than 2020.

January 2022 YTD Labor Cost was \$1.16 cents per meal. Despite industry wide labor increases of 30%, Glassboro is \$0.13 less than 2020


January 2022 YTD Surplus is \$106,532. While this is a great return above budget, there is not enough money being used in the operation to improve food and service.

▲ January 2022 YTD Overall Breakfast Participation was 36% which is 5% less than 2020 despite all meals being free.


→ January 2022 YTD Overall Lunch Participation was 45% which is 4% less than 2020 despite all meals being free.

The numbers, metrics, and on-site visits show that Chartwells needs to improve food quality and increase staffing levels to offer the retail style service that is expected.
