# Food Service Dashboard Glassboro - January 2023



On the following pages are the Dashboard's month and year to date results for your food service program displayed in an easily read graphical display.




#### **Glassboro Food Service Budget Exceptions 2022-2023**


2. All exceptions must be submitted on the following form. The form will be used as a running summary of all exceptions requested and approved.


















#### Middle Schools Overall Participation Rates










