
- While the YEAR to DATE cost metrics are below the industry metrics, these costs are actually too low and indicate a disruption to acceptable service. February was trending in a
- March 2022 YTD Food Cost was \$0.98 cents per meal. All districts have seen 10-15% increases in food cost, Glassboro is \$0.15 cents less than 2020.
- March 2022 Food Cost for the month was even lower at \$0.77 cents per meal
- March 2022 YTD Labor Cost was \$1.09 cents per meal. Despite industry wide labor increases of 30%, Glassboro is \$0.40 less than 2020
- March 2022 YTD Surplus is \$195,993. While this is a great return above budget, there is not enough money being used in the operation to improve food and service.
- March saw an increase in lunch participation for the second straight month. Total Lunch Participation was 68%
- Chartwells has been working on an action plan for improvement. The March trends show they are making progress in the overall operation.
- Chartwells is still facing a staffing shortage. They currently have 6 open positions.

















Glassboro School Participation Charts
