For a quick snapshot the following is a "Report Card" of the results for the past month and year to date.


















## **Glassboro Food Service Budget Exceptions 2022-2023**

- 2. All exceptions must be submitted on the following form. The form will be used as a running summary of all exceptions requested and approved.
- 3. Any budget exception not submitted with in the 14 days (other than enrollment, ADA, number of free and reduced, number of feeding days and commodity levels) will NOT be
