

Glassboro School District Motion to Approve Nutri-Serve Food Management for the 2014-15 School Year

Motion to approve Nutri-Serve Food Management Inc as the food service management company for Glassboro School District the 2014-15 school year.

Cents per meal Management Fee

This is calculated in two parts.

- 1) The number of School Breakfast Program, National School Lunch program, and After School Snack meals served to children shall be determined by actual count. **The per meal management fee for "Student Meals" is \$0.1400 per student reimbursable meal.** The term "Student Meals" refers to reimbursable Student Breakfast, Student Lunch, and After School Snack.
- 2) Cash receipts, from sales other than reimbursable meals, shall be divided by **\$1.00** to arrive at the meal equivalent count. **The per meal management fee for Meal Equivalents is \$0.1100 per meal equivalent.**

The total management fee will be the addition of these two amounts based on the sales activity each week. It is anticipated that the management fee total for 2014-15 will be \$50,456.00.

Guarantee

Nutri-Serve Food Management Inc guarantees that the bottom line on the operational financial report for the school year 2014-15 will be a **Return of \$50,000.00**. If the actual bottom line on Nutri-Serve Food Management's Operational Financial Report is less than **\$50,000.00**, Nutri-Serve will subsidize the difference in the bottom line to Glassboro School District.
