**RESOLUTION AUTHORIZING THE COUNTY TO ENTER INTO DIRECT
CONTRACTS FOR JUVENILE SERVICES, FOR A TERM OF THREE YEARS FROM
JANUARY 1, 2018 TO DECEMBER 31, 2020**

WHEREAS, the County of Gloucester has a need to offer programs within the schools for the citizens and youths of Gloucester County; and

WHEREAS, the Gloucester County Department of Health and Human Services has recommended that said services be provided by Glassboro Board of Education with offices at 560 Joseph Bowe Blvd., Glassboro, NJ 08028, in an amount not to exceed \$16,848.00 per year, from January 1, 2018 to December 31, 2020; and

WHEREAS, the Gloucester County Department of Health and Human Services has recommended that said services be provided by; Paulsboro Public Schools with offices at 662 North Delaware Street, Paulsboro, NJ 08066, in an amount not to exceed \$21,000.00 per year, from January 1, 2018 to December 31, 2020; and

WHEREAS, the Gloucester County Department of Health and Human Services has recommended that said services be provided by Woodbury Board of Education with offices at 25 North Broad Street, Woodbury, NJ 08096, in an amount not to exceed \$50,000.00 per year, from January 1, 2018 to December 31, 2020; and

WHEREAS, the contract was awarded consistent with the fair and open provisions of the Gloucester County Administrative Code and pursuant to N.J.S.A. 40A:11-5(2).

NOW, THEREFORE, BE IT RESOLVED by the Board of the Chosen Freeholders of the County of Gloucester that the Director of the Board is hereby authorized to execute and the Clerk of the Board is hereby authorized to attest to execute the contracts for various school programs for citizens and youth of Gloucester County, each for a period of three years, from January 1, 2018 to December 31, 2020 to Glassboro Board of Education, in an amount not to exceed \$16,848.00 per year; Paulsboro Public Schools, in an amount not to exceed \$21,000.00 per year; Woodbury Board of Education, in an amount not to exceed \$50,000.00 per year; and

BE IT FURTHER RESOLVED, these services are provided on an as-needed basis and are therefore open-ended; before any purchase is made, a certification must be obtained from the County Purchasing Agent certifying that sufficient funds are available at that time for that particular purchase, and identifying the line item in the County budget out of which said funds will be paid.
