<u>Agreement to Provide Additional Remedial Services</u> for Nonpublic Title 1 Students

2016-2017 School Year

In consideration of the terms and conditions set forth below, Gloucester County Special Services School District (referred to as GCSSSD) and GLASSBORO School District (referred to as the District), it is agreed as follows:

- 1. GCSSSD shall provide to the District local district TITLE 1 instructional services for eligible nonpublic students who attend a nonpublic school in the District during the school year, 2016-2017, effective September 6, 2016 with services to begin October 18, 2016, contingent upon receipt of student list and terminating June 30, 2017. The instruction will be provided in compliance with all applicable federal and state regulations at the site of the nonpublic students' school. GCSSSD will maintain the student records at GCSSSD and on site at the nonpublic school.
- 2. The District shall provide the initial list of eligible TITLE 1 nonpublic school students to be served.
- 3. The District shall pay GCSSSD a sum of \$900 per service for the year. Fees will be prorated from date services are initiated. Payments shall be made within forty-five days from date of bill.

Available services:

Math – 30 minute weekly session Reading – 30 minute weekly session

Writing – 30 minute weekly session

- 5. This Agreement constitutes the entire understanding of the parties with respect to the matters contemplated and dealt with hereby. Any modifications or changes hereto shall be in writing and signed by both parties.
- 6. If any provision or part of this Agreement shall be deemed unlawful or invalid for any reason, only such provision(s) or part(s) shall be eliminated, and the remaining provision(s) or part(s) hereof shall remain valid and binding upon the parties.

Agreement to Provide Additional Remedial Services for Nonpublic I.D.E.A. Students

2016-2017 School Year

In consideration of the terms and conditions set forth below, Gloucester County Special Services School District (referred to as GCSSSD) and GLASSBORO School District (referred to as the District), it is agreed as follows:

- 1. GCSSSD shall provide to the District local district I.D.E.A. instructional services for eligible nonpublic students who attend a nonpublic school in the District during the school year, 2016-2017, effective September 6, 2016, and terminating June 30, 2017. The instruction will be provided in compliance with all applicable federal and state regulations at the site of the nonpublic student's school. GCSSSD will maintain the student records on site.
- 2. The District shall confirm the initial list of eligible I.D.E.A. nonpublic school students to be served.
- The District shall pay to GCSSSD a sum not to exceed the I.D.E.A. allotment for the 2016-2017 school year. Payments shall be made within forty-five days from date of bill.
- 4. Notice of termination of services 2016-2017 for the school year must be provided in writing by either party by June 30, 2017.
- 5. This Agreement constitutes the entire understanding of the parties with respect to the matters contemplated and dealt with hereby. Any modifications or changes hereto shall be in writing and signed by both parties.
- 6. If any provision or part of this Agreement shall be deemed unlawful or invalid for any reason, only such provision(s) or part(s) shall be eliminated, and the remaining provision(s) or part(s) hereof shall remain valid and binding upon the parties.

GLOUCESTER COUNTY SPECIAL SERVICES SCHOOL DISTRICT Agreement to Provide Chapter 226 Nonpublic Nursing Services 2016-2017 School Year

This agreement made this 8th day of September, 2016, by and between the Board of Education of the Gloucester County Special Services School District (hereinafter referred to as GCSSSD), and the Board of Education of the GLASSBORO Public School District, (hereinafter referred to as the District).

WHEREAS,

the Legislature of the State of New Jersey has found and determined that the welfare of the State requires that all school-age children be assured equal access to appropriate health care services; and,

WHEREAS.

P.L. 1991, Chapter 226 provides that each Board of Education of a district in which a nonpublic school is located shall provide certain nursing services and may provide additional medical services to those students who are enrolled full time in the nonpublic school;

NOW, THEREFORE,

in consideration of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. <u>Nursing Services to Nonpublic Schools</u>

GCSSSD shall provide the following nursing services for pupils within the District who are enrolled full time in the nonpublic school, subject to the limitations set forth in Sections 3, 4 and 5 below:

- Assistance with medical examinations, including dental screening;
- b. Conducting screening of hearing examinations;
- The maintenance of student health records and notification of local or county health officials
 of any student who has not been properly immunized;
- Conducting examinations of pupils between the ages of 10 and 18 for the condition known as Scoliosis; and
- e. Conducting vision screenings.

2. Additional Medical Services

To the extent the funding for nursing services set forth in paragraph 6 below is available, GCSSSD may provide equipment and materials authorized under P.L. 1991, Chapter 226.

Instructional Services Not Included
 GCSSSD shall not provide instructional services to nonpublic schools in connection with the provision of services referred to above

4. Nonpublic School Declining Nursing Services

A nonpublic school may decline the nursing services which are provided for herein by submitting written notification to the District from the appropriate administrator of the nonpublic school. The District will inform GCSSSD in writing that it is relieved of responsibility hereunder for providing such services.

5. Parent or Guardian Objection

A pupil who is enrolled in a nonpublic school and whose parent or guardian objects to the pupil receiving any services provided hereunder shall not be compelled to receive the services except for a physical or medical examination to determine whether the pupil is ill or infected with a communicable disease pursuant to N.J.S.A. 18A:40-30. In the event that a parent or guardian objects to the pupil receiving any nursing services provided for herein, GCSSSD is relieved of responsibility hereunder for providing such services.

- 6. The District agrees to pay GCSSSD a sum equal to the full funding allocated by the State Department of Education for nursing services to nonpublic schools within its district pursuant to the provisions of Chapter 226, Laws of 1991. Billing will be based upon the nonpublic school enrollment on the last school day prior to October 16 of the preceding school year. Districts shall pay GCSSSD in full based on the District's schedule of funding from the State Department of Education.
- Notice of termination of services for the 2017-2018 school year must be provided in writing by either party by March 15, 2017. In the absence of such notice by either party, this contract commits the District to receiving and paying for Chapter 226 Nursing Services from GCSSSD for the 2017-2018 school year.
