2	ELA staff to be trained in Reader's Workshop and Close Reading (tiered vocabulary)	Training for Reader's Workshop and Close Reading. ELA teachers to present overview to all staff for integration of instructional terminology.
3	Recruit staff members to turnkey information gained from reading <i>Total Participation Techniques</i> by Himmele & Himmele. Provide time for the "team" to prepare for presentation.	Have team present findings at a faculty meeting or in-service day.
