In explaining the background to the dirty look, Victim 1 details a group chat that was sent the night prior.</p> <p>Victim 1 reports that she was at a friend's house over the weekend (9/6/25-9/7/25). While at the friend's house, Victim 1 got into a verbal argument with a student that used to attend Glassboro High School (GHS). This student accused Victim 1 of having sexual relations with Offender 1. Shortly after the argument, Victim 1 was added into a group chat that included Offender 1, Witness 1, Witness 2 and Witness 3. Messages from Offender 1 and Witness 3, targeted Victim 1's medical condition as well as physical threats. Messages from Witness 2 targeted Victim 1, calling her a "whore" and referring to Victim 1 having "no butt."</p> <p>Messages from Witness 1 did not send any negative messages towards Victim 1.</p> <p>Victim 1 reported that she did block all students in the group chat and deleted them from social media.</p> <p>September 9, 2025- ABS, GC1 and SRO spoke with Glassboro Police Department (GPD). Due to the threat, GPD is filing a complaint. Complaint number is # 2025-029912</p> <p>September 9, 2025- VP1 pulled Victim 1 and Witness 2 and held a peer mediation, as Witness 2's involvement was due to her current relationship with Offender 1. Witness 2 apologized for being involved in the group chat. This HIB report was a collaboration between Bowe Middle School admin and counseling team as well as the Glassboro High School admin and counseling team to ensure the bullying behaviors were addressed as they continued to effect the 2025-2026 school year.  The motivating characteristic in this report, are characteristics revolving around the appearance/weight of Victim 1. Reports that Offender 1 bullied Victim 1 about her weight is confirmed. Statements from Witness 3, Witness 4, Witness 5 and Witness 6 all support this report.  This took place on the property of the school, specifically in class and the cafeteria.  Substantial disruption is evident as this incident is affecting the learning environment of Victim 1.  Following this HIB, Offender 1 will have check-ins with the Vice Principal. Additionally, Offender 1 will meet with the ABS at minimum 3 times to address bullying behaviors.
