We are the early childhood center located in the Glassboro Public School district. We have just under 300 students ages 3-6 who are enrolled in Preschool, Pre-Kindergarten and Kindergarten. We provide a half day program for Preschool and Pre-Kindergarten students and full day Kindergarten. Our school will be expanding to a full day 4 year old Pre-Kindergarten next school year.

We currently have a playground that is suitable for our Kindergarten students. It is appropriate for students ages 5-12. We do not have any playground equipment for half of student body, the Preschool and Pre-Kindergarten students. These students get no playground time. Our district is moving towards full day Pre-Kindergarten and is interested in implementing more playground time and purposeful play. We need something safe for these children to climb on and work on their gross motor skills. Many of these kids come from poverty, broken homes, and have suffered trauma in their young lives. We want them to have a place where they can play, make friends, and have fun every single day. One of the reasons why we are applying for the grant is our district is losing 1.8 million dollars in state funding this year.

We have tried through fundraising for years to get a small playground. Although our PTO has some money saved, it's just not enough. Our current playground is not appropriate for most of the students we serve. It's very intimidating for kids and there have been students who have gotten hurt, even broken bones, while playing on it. This grant would mean the world to our students.
