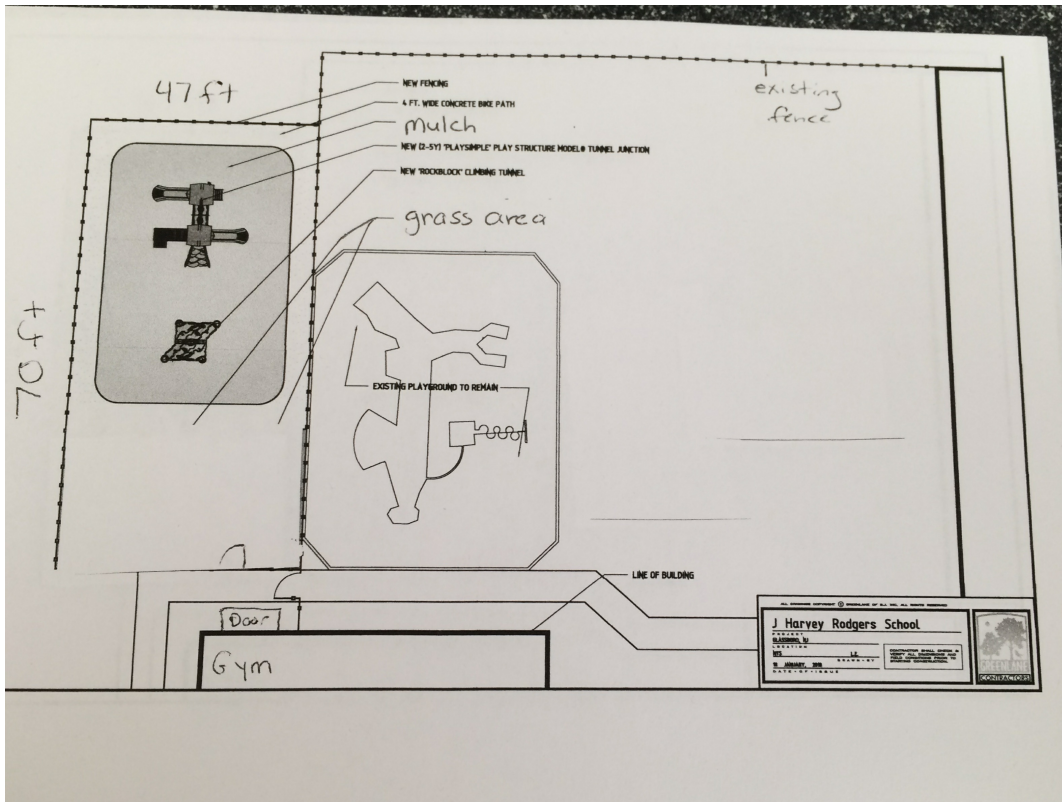

Site Map

Using either pen and paper or a computer program such as Word or Paint, create a simple sketch of your proposed playground site. Make sure you have checked-off all the boxes on the Site Map Checklist below before you upload your site map! For an example, click [here](#).

Site Map Checklist:

- **Site Dimensions:** Measure both the length and width of the site (ex- 47' x 53')
- **Access points:** If there is a gate, stairs, or a fence surrounding the site, show where it is located in your drawing. Highlight any access points.
- **Physical Characteristics:** Trees, fences, buildings, existing playground equipment, sloping, in-ground drains, retaining walls, etc.



Big Picture - Site Photo

- **360°:** Stand in the center of the space where you will build your playground and take four different photos facing North, South, East, and West. These four photos will let us see what is visible from your proposed playground site.

Jace is a little boy who was in foster care along with his 3 older and 1 younger sister. He was adopted by a family who lives on the "Ridge", which is the neighborhood in which this school is located. Jace is a special needs child who will be attending our Kindergarten program this year and his younger sister is attending our 4 year old program. Our current playground for students age 5-12. Although Jace is 5, it's very intimidating for him. He rather run around on the grass at recess and avoid the large playground. It would be so wonderful if he could have a smaller structure to climb on to help him develop his gross motor skills. Last year, Jace did not get any playground time and neither will his little sister since she is going to be 4 years old. The reason is our current playground is not safe for younger children. Unfortunately, students have broken bones by falling from the monkey bars and fire pole.

We are the only public school district that offers a free 3 and 4 year old program. Half of our school population has no playground to play on. Many of these kids live within walking distance to our school and would use the playground all year round.

Many of the students in our district come from broken homes. They are being raised by grandparents or single parents. These family members are working so hard to provide for their families. We have been fundraising for a new, smaller playground for over 10 years. We have some money saved by not enough. Our district is getting cut 1.8 million dollars in our school year budget for this school year. Our class sizes are rising. I have the most amount of kids in my class in the 12 years I've worked at Rodgers. These kids need an appropriate place to play. We are adding purposeful play into our schedule. This would be extra time we could spend outside, developing social skills and gross motor skills. These kids want to be outside, learning and growing. Please help us do that by awarding us this grant.
