Eligible CSI, ATSI and TSI schools must continue to implement, and progress monitor their approved Annual School Plan (ASP) for the 2023-2024 school year. Additionally, pursuant to N.J.A.C. 6A:33 the Chief School Administrator must submit a sustainability plan for each eligible CSI school, within 30 business days of this notice. The Department will host the following virtual technical assistance session, via Microsoft Teams, for school districts and schools to engage in dialogue with Department staff regarding the sustainability planning requirement. Schools that are exiting either ATSI or TSI are not required to complete a sustainability plan but are required to continue completing an ASP for a Title I schoolwide program, if applicable, pursuant to the ESSA.
