Part of the 2015 referendum project was to upgrade existing clock and speaker systems with networked systems. In an effort to reduce the initial estimated cost of the referendum, several clocks/speakers were removed from the scope of work. We are at the end of the project and have unspent referendum funds. Attached is a proposal from NWN to supply and install additional networked clocks and speakers that were value engineered out or omitted from the original project. The original purpose of the bond and the attached proposal were review by bond counsel and it was determined the additional work does not constitute new work or an expansion of the original purpose of the bonds.

Recommend the board approve the proposed contract with NWN to supply and install additional networked clocks and speakers. Total cost of proposal is \$204,487.64 to be paid with referendum funds.
