Progress Update – Rehab Projects – Newport Contract

- All work is substantially complete as of October 2017.
- Minor punchlist activities remain.
- Contractor is demobilized from site as of December 18, 2017.
- We have HVAC training to conduct on controls systems.
- Change orders are up to date and some additional Owner requested work items are now being priced/negotiated.
- The GBOE has received excellent value for their construction budget and a lot of work, that was not initially awarded in the base bid, has been completed at each school via contract allowances and change orders.
- On Time Both phases of invasive, comprehensive renovation work at all buildings has been completed on time with no occupancy delays at any school building.
- <u>Under Budget</u> All work has been completed within original budget
- No Disputes There are no lingering contract dispute or claims.
