NOW THEREFORE, the parties hereto agree to the scope and nature of the services as follows:

- 1. The terms and conditions of this Agreement shall be in effect from July 1, 2018 through June 30, 2019.
- 2. GCSSSD will offer each nonpublic school serviced by this contract, subject to receipt of appropriate applications for services and funding, the listed minimum time allotments of services. Services will be provided by NJDOE licensed staff members. Records will be maintained at the GCSSSD administrative offices. Services will be provided in the nonpublic school and/or an approved temporary classroom unit provided by GCSSSD.
  - a. **Compensatory Education** One (1) thirty-minute or one (1) forty-five minute session weekly per subject.
  - b. **E.S.L.** Two (2) thirty-minute periods or one (1) forty-five minute period per week.
  - c. **Supplementary Instruction** Two (2) thirty-minute periods or one (1) forty-five minute period per week.

- d. Speech Correction One (1) thirty-minute period per week.
- e. **Home Instruction** Minimum of five (5) hours per week in not less than three (3) visits per week.
- 3. Examination/Classification will be provided to students who are identified by the nonpublic school as having potential learning difficulties. All examinations and/or classifications will be conducted in accordance with N.J.A.C. 6A-14 et seq. by appropriately certified personnel.
- The District agrees to pay GCSSSD per student served the maximum fees listed.
   The cost breakdown of Chapters 192 and 193 includes all program costs.

- If additional funding requests result in lower per student funding from the State Department of Education, GCSSSD agrees to bill at the reduced rate or if the State Department of Education funds additional requests at a higher rate, GCSSSD will bill at that rate. However, the District must submit additional funding requests as needed.
- The District agrees to pay GCSSSD for all Home Instruction as said services are rendered by GCSSSD within forty-five (45) days following receipt of invoices for such services at the following rates:

- 7. The following services will be billed on a monthly basis.
  - \$ Compensatory Education
  - \$ English as a Second Language
  - \$ Speech Correction
  - \$ Supplementary Instruction

8. Notice of termination of services for the 2018-2019 school year must be provided in writing by either party by December 31, 2017. In the absence of such notice by either party, this contract commits the District to receiving and paying for Chapter 192/193 services from GCSSSD for the 2018-2019 school year.
