SECTION 1 BUSINESS CASE

Glassboro Public Schools, hereafter referred to as Glassboro, is seeking a hyper-converged solution to replace their aging servers and storage.

This project will benefit the school by optimizing the efficiency of the servers and storage and improving their resiliency and security. The Nutanix platform, because of its revolutionary approach to combining servers and storage in one block eliminates bottlenecks that slow down typical server-storage setups. It comes out of the box with a self-healing military level Security Technical Implementation Guide (STIG). Its advanced software removes planned downtime and reduces unplanned downtime by over 90%. The school will also reap benefits in shorter troubleshooting response times thanks to the single pane of glass management and highly rated single vendor hardware support. Finally, there will be significant savings seen in lower power and cooling requirements, resulting in a greener facility.

SECTION 4 IMPLEMENTATION STRATEGY

4.1 Nutanix Initial Setup and Configuration


1. Proper configuration of Nutanix before it is deployed into the virtualization environment. Once PBG has the cluster up and running, PBG will upgrade the Nutanix Operating System to the latest version of NOS.

Since the storage is the backbone of the virtualization environment, we recommend 1 day of testing Nutanix with test virtual machines before deployment. This allows us to verify the integrity of the storage. We will test connectivity, input/output (I/O), and verify operations.





- 2. One Four Node ESXi Cluster will be created on Nutanix along with a virtual vCenter Server, along with the latest version of VMware. PBG will upgrade to the latest version of vSphere. PBG will also create a new vCenter server for the virtualization environment. VMware highly recommends virtualizing vCenter Server as it removes a single point-of-failure along the ESXi Cluster. This vCenter will serve as the control panel for bringing the remote site online. Since CLIENT has purchased the VMware Standard Suite, the following capabilities will be configured.
 - vCenter High Availability (HA)
 - vSphere vMotion
 - Storage vMotion
 - Data Protection
 - Clustering
 - vSwitches
 - vSphere Replication
 - VMware Update Manager







4.2 VM and Data Migration

1. Migrate Virtual Servers from old EMC environment to new Nutanix 4 Node Cluster. Once VMware VMs have been migrated the local VMware tools install will be upgraded as well as the virtual hardware interface. The VMware process must be performed exactly to avoid corrupting the VM. snapshots will not repair the VM in a case where the VM no longer functions.



4.3 Testing and Knowledge Transfer

- 1. PBG will conduct testing of the vCenter and all native functions of VMware along with the Nutanix cluster.
- 2. Support and Training of the Virtual environment and Nutanix via certified training personnel. PBG is an authorized Training Center for VMware and Nutanix and various other vendors via Global Knowledge. PBG will train CLIENT to handle and take over virtual environment management, maintenance, and upgrade. Training allows PBG to help CLIENT get the biggest return on investment (ROI) and allows CLIENT to completely take over environment after implementation has finished.
