To recap our discussion last week, the Child Connection Center (CCC) will expand its services in Glassboro School District to include the Thomas E. Bowe School beginning September 2015. The CCC can currently offer each of our participating school districts 4 days worth of services per week (2 days each for social work support and behavior support.) Services at the Intermediate School will continue; but, the days of service will be shared with Bowe and divided up according to the level of need presented by families from both schools.

As we discussed, the CCC staff will bring their own laptops and supplies. We ask that Bowe provides the CCC staff with space where they can hold individual and small group counseling sessions for students/families as well as space where the staff can work at their computers and access email, internet, and phone lines.
