Sections 1 and 4 of the current Guides read as follows:

- 1. [Teaching (3230) or Support (4230)] staff members are advised to refrain from conduct, associations, and offensive speech that, if given publicity, would tend to have an adverse or harmful effect upon pupils or the school community;
- 4. [Teaching (3230) or Support (4230)] staff members shall not campaign on school grounds during their work day, send campaign literature home with pupils, or request, direct, or have pupils distribute campaign literature on behalf of any candidate for local, State, or national office or for any bond issue, proposal, or any public question submitted at any general, municipal, or school election;

Section 1 aligns with some recent legal cases regarding staff members posting inappropriate comments regarding their school and students. In <u>In The Matter of the Tenure Hearing of Jennifer O'Brien, State-Operated School District of the City of Paterson, Passaic County, DKT. NO. 108-5/11, Commissioner of Education, 12 December 2011, it was determined the teacher's negative postings about her students and the school were not constitutionally protected and the ALJ/Commissioner terminated the tenured teacher for these inappropriate postings. Section 4 aligns with N.J.S.A. 18A:42-4 – Distribution of literature as to candidacy, bond issues, or other public questions to be submitted at election; prohibited.</u>

Recently, a school district's local education association challenged sections 1 and 4 of the school district's Policy 3230. These sections of the district's Policy are consistent with Strauss Esmay's Policy Guide 3230. In light of this challenge, even though the Policy Guide language is consistent with case law and statutes, it is recommended section 1 of the Strauss Esmay Policy Guides be removed and section 4 be revised. These revisions will not impact any Board management rights as these sections were only included in these Policy Guides to provide direction and guidance to protect staff and not to infringe on any staff member's rights. Therefore, Policy Guides 3230 and 4230 have been revised accordingly. A Board wanting to keep these provisions in these Guides may want to review the issue with their Board Attorney. These Policy Guides are not mandated.

3230/4230 - Outside Activities (Revised)

Policy and Regulation Guides 3230 and 4230 – Outside Activities have been updated to address some recent concerns expressed by several school districts. These Guides disclaim the school district's responsibility for any trip not approved by the Board which is sponsored by school district staff members on their own time. Both Guides revise language to prohibit a school staff member devoting time during their workday for any private enterprise, business, or business organization without specific approval of the Superintendent and prohibits campaigning on school grounds during the workday. A school district may revise these Guides as the only provision in the law is the campaign prohibition outlined in N.J.S.A. 18A:42-4.

3230 <u>OUTSIDE ACTIVITIES</u>

The Board of Education recognizes that teaching staff members enjoy a private life outside their job responsibilities in the school district. The Board believes the role of the teaching profession is such that teachers exert a continuing influence away from the school district. Accordingly, the Board reserves the right to determine if activities outside the teaching staff member's job responsibilities interfere with their professional performance and the discharge of the member's responsibilities to the students of this district.

All teaching staff members are advised to be governed in the conduct of personal activities by the following guidelines:

- 1. Teaching staff members shall not devote time during their work day to an outside private enterprise, business, or business organization. They shall not solicit or accept customers for a private enterprise, business, and/or business organization on school grounds during their work day without the express permission of the Superintendent;
- 2. The Board does not endorse, support, or assume liability in any way for any staff member of this district who takes students on trips not approved by the Board or Superintendent, and shall not be liable for the welfare of students who travel on such trips. Any staff member who takes students of this district on a trip not approved by the Board or Superintendent shall clearly and concisely inform the parent(s) of any student solicited and/or attending such a trip that the trip is not endorsed, supported, approved, or authorized by the Board of Education. A staff member shall not solicit students on school grounds for trips not approved by the Board or Superintendent;

- 3. The Board does not endorse, support, or assume liability in any way for any teaching staff member of this district who conducts a private activity in which students or employees of this district participate;
- 4. Teaching staff members shall not send campaign literature home with students, or request, direct, or have students distribute campaign literature on behalf of any candidate for local, State, or national office or for any bond issue, proposal, or any public question submitted at any general, municipal, or school election. No student shall be requested or directed by any teaching staff member to engage in any activity which tends to promote, favor, or oppose any such candidacy, bond issue, proposal, or public question;
- 5. Teaching staff members shall not privately tutor students for compensation that are currently enrolled in their classes; and
- 6. Copyrights and patents to materials or equipment developed, written, prepared, processed, or tested by teaching staff members in the performance of their professional duties reside with and may be claimed by the Board.
