Reconstructive Orthopedics ("RO") and Board of Education of the Glassboro School District ("GLASSBORO") are entering into the below outlined service contract as the provider of a sports medicine physician for coverage during home Glassboro High School football games. These coverages will be for the 2022 football season. This contract shall be effective as of July 1, 2022 and end on June 30, 2023.

The following coverage, services and support will be provided to GLASSBORO by Reconstructive Orthopedics physicians and staff for the term of this agreement. Services are subject to change. Reconstructive Orthopedics will provide thirty (30) days' notice for any services that are discontinued during that time this agreement is in effect.

- Reconstructive Orthopedics will provide a sports medicine physician at home Glassboro High School football games on the dates set forth on Schedule A. Reconstructive Orthopedics physicians shall be on site at least 15 minutes prior to kickoff and depart upon completion of evaluation of all injured athletes, if any. Coverage will not be provided for away games unless specifically requested and agreed to in advance. Additional coverage and away coverage is subject to additional compensation to be mutually agreed upon.
- Concierge services provided to players, coaches and athletic training staff to include
  - ATC Assist: This service is provided to athletic trainers and coaches that require the ability to connect with clinical staff 24/7. Clinical staff can be contacted via email at <u>ATCAssist@reconstructiveortho.com</u> 24/7 for assistance.
  - MVP Athlete Access: Athletes, parents, and coaches will be provided access to expedited care and dedicated service through MVP Athlete Access by calling (856) 641-0770



- Reconstructive Orthopedics shall provide proof of appropriate general liability insurance coverage naming GLASSBORO as an additional insured. In addition, Reconstructive Orthopedics agrees to indemnify and otherwise hold GLASSBORO harmless for any acts of negligence relative to their employees providing services under the terms of the herein agreement. Said indemnification is intended to cover both GLASSBORO employees, officers as well as any thirdparty participants in the GLASSBORO sports programs.
- Compensation: For services rendered by Recontructive Orthopedics under this compensation, Reconstructive Orthopedics shall be paid \$200 per game.
   GLASSBORO will be invoiced at the conclusion of the 2022 fall football season.
