RESOLUTION OF THE BOARD OF EDUCATION OF THE BOROUGH OF GLASSBORO, IN THE COUNTY OF GLOUCESTER, NEW JERSEY CERTIFYING THAT A QUANTITATIVE OR QUALITATIVE MERIT CRITERION HAS BEEN SATISFIED.

WHEREAS, The Board of Education of the Borough of Glassboro, in the County of Gloucester, New Jersey ("Board" when referring to the governing body and "School District" when referring to the legal entity governed by the Board) has entered into a contract with the Superintendent that was approved by the Board of Education and the Executive County Superintendent (ECS) pursuant to N.J.S.A. 18A:7-8(j) and N.J.A.C. 6A:23A-3.1(a).

WHEREAS, N.J.A.C. 6A:23A initiated salary caps which requires the CSA contract to be capped through its life from July 1, 2014 through June 30, 2015; and

WHEREAS, the School District supports and encourages innovation and progress toward attainment of district goals and student achievement; and

WHEREAS, Merit goals were created by the board of education in consultation with the employee, and pursuant to the requirements of N.J.A.C. 6A:23A-3.1(e)10 and 11, the goals are to be a specific part of the contract and submitted to the ECS for review and approval; and

WHEREAS, the ESC approved the merit goals on November 14, 2014; and

WHEREAS, the Glassboro Board of Education evaluated the Superintendent and certifies that the quantitative and qualitative merit criterion has been satisfied, in part, as noted it the evaluation.

WHEREAS, The ECS must provide the board with confirmation that the criterion has been satisfied prior to payment of any merit bonus. [N.J.A.C. 6A:23A-3.1(e)10iv]
