The Goucester County Engineering Department in conjunction with the NJSON, Rowan University and the Borough of Glassboro has conducted a Concept Development study to explore the installation of a bypass of Route 322 on and around Rowan University. The study concluded that there is a public need to notice the impact of vehicular traffic in that area thereby addressing the safety of pedeatrians, bicyclists, and motorists, improving traffic operations, and reducing traffic in the vicinity of the University.

The Route 322 Bypass of Rowan University Concept Development Study was initiated to address operational and safety concerns along Route 322 Route 47, and High Street around Rowan University for this project. The proposed downtown business alternate bypass would utilize Girard Road and High Street to divert car traffic around the university. The County also required that a truck bypass be studied that will utilize Elis and Sewell Streets as well as Rt 55 & Dr. Leo McCabe Boulevard to divert Route 322 truck traffic to roadways outside of downtown Glassboro.

As with many road improvement project of this magnitude, privately owned properties located along the project area often must be partially or totally acquired as part of the engineering design. Your property has been identified as one that is along the project route and will be impacted by this project. We would like to meet with you and discuss the project and steps to expect moving forward. This meeting is for information purposes only.
