2022-2023 Comprehensive Needs Assessment – *Narrative*

Comprehensive Needs Assessment was completed utilizing the data collected from MAP and Start Strong assessments along with a survey that was conducted (see attached) to determine the needs of the school. Attendance and graduation rates were also examined to determine if there was a need for interventions in those areas. PowerSchool reports, NJSmart reports, and school report cards were utilized to collect and compile data for student subgroups. The survey revealed that many teachers in need of additional professional development in interpreting and utilizing MAP data and would like more support in the areas of RTI/MTSS supports and Tier I interventions. The teachers and administrators utilize data gathered from MAP assessments along with classroom assessments and performance to identify educationally at-risk students and begin to implement interventions in a timely manner. Interventions are provided in the classroom by the classroom teacher, through remediation courses, and through extended school day programs. The transition from targeted Title I funds to schoolwide Title I funds would allow us to reach more students through intervention and enrichment programs at the 9th through 12th grade levels.


