I spoke with Sandy at Strauss Esmay. They do now have a service to provide read only access to the general public to all policies (\$395/yr), and regulations (\$100/yr). They can get it set up within a few days and we provide a link on our webpage, like we do now for the board members.

It would cost more than \$500 to a \$10/hour person download and convert every policy and then upload and create a link on our website. It probably costs close to \$500/year in time Betty Ann does not to download, convert and post the policy changes we do each year.

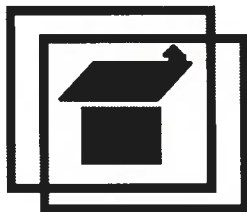

1. SEA will provide the district with a URL address to be placed on the school district website by school district personnel. The URL will link to the district's bylaws and policies. The bylaws and policies will be searchable by individual sections of the policy manual and by a word search feature.
2. PUBLICACCESS*Online* is a service available only to DISTRICT*Online* clients. PUBLICACCESS*Online* does not provide links to authorizing statutes, administrative codes, and *New Jersey School Digest* cases.
3. There is an additional fee for PUBLICACCESS*Online* – Bylaws and Policies.

The 2016-2017 annual fee for PUBLICACCESS*Online* – Bylaws and Policies is \$395.00 in addition to the PASS and DISTRICT*Online* annual fees. This fee shall be prorated the first year from the first day the district's manuals are available to the district on DISTRICT*Online* to June 30.
