During the summer of 2015 the Glassboro Board of Education sponsored a summer feeding program located at the Bullock School. The program fed an average of 54 residents per day during the month of July. The operation resulted in a net loss to the district of \$1,784.65.

Through conversations with NutriServe, it has been determined that the board can participate in the Summer Feeding Program by entering into an agreement with the Food Bank of South Jersey. The Food Bank of South Jersey will administer the program and deliver food to the site of our choice. The board's only responsibility will be to provide a count of the meals actually served each day. There will be no cost to the district to participate in this agreement.

Based on the above fact I would like to recommend the board enter into an agreement with the Food Bank of South Jersey to participate in the Summer Feeding program at the Bullock School.

The Food Bank of South Jersey (FBSJ) is proud to once again participate in the Summer Food Service Program (SFSP) from June 13th, 2016 to September 2nd, 2016. It is anticipated that over 2,600 children will receive free meals in Summer Schools, Day Camps, Libraries, Churches, Hospitals, medical clinics, WIC offices, community non-profit organizations, and local parks. In all, we have a community collaborative with 45 entities that are committed to establishing summer food locations throughout South Jersey.

This program, under the sponsorship of the United States Department of Agriculture's Food and Nutrition Services, provides all children up to 18 years of age with free meals to help fill the nutrition gap of the nearly 75% of our children who are eligible to receive free or reduced meals during the school year. The menu and program operations are under the auspices of the State of New Jersey, Department of Agriculture, Division of Food & Nutrition. The Food Bank of South Jersey Program is always seeking to add new sites and activities that will broaden community outreach and help draw children to our existing program.
