

REQUEST

In the past years, there has been a historical dip in writing skills for students in 7th and 8th grades, especially those who are considered at-risk due to their socioeconomic status. WriteStart Boot Camp Program is requesting funding through the CDBG in the amount of \$26,871.00. This funding will be used to create a program which provides at-risk students entering 7th and 8th grades in September 2015, with a research-based program that will allow them to extend their writing and literacy skills. WriteStart Boot Camp will give students a passion for writing and empower them to realize that they are lifelong learners. Their skills need to be boosted so that when they enter Glassboro Intermediate School in September, they will have an easier transition into Intermediate's rigorous Language Arts Literacy curriculum. We wish to extend this opportunity to all at-risk students, including those living in subsidized housing throughout the district, those that have free or reduced lunch, and those who struggle with academic literacy.

PROGRAM DESCRIPTION

The WriteStart Boot Camp Program was developed to change the attitude of low income families living in public assisted housing, and impress upon them the importance of writing, not only in the school setting, but writing as it applies to real world situations. WriteStart Boot Camp is designed for all students who are transitioning from the elementary to the middle school setting, as well as those entering 8th grade whose literacy skills need additional remediation. Our philosophy considers each child's writing development as a joint responsibility, shared by teachers and parents. The WriteStart Boot Camp will invite parents to take an active role in their child's middle school writing activities and emphasize the importance of providing positive learning experiences for their children.

The WriteStart Boot Camp curriculum is aligned to the curriculum of the Glassboro Public Schools and the Grades 7 and 8 Core Curriculum State Writing Standards. The learning environment, activities, and interactions are research-based. Each writer's experience is designed to progress with the knowledge of each child's interests, abilities, needs and background.

Writing standards will be addressed to ensure children have a head start on the NJDOE writing criteria as they transition from the elementary setting to secondary educational standards. Types of writing will include: writing arguments to support claims with clear reasons and relevant evidence; writing informative/explanatory texts to examine a topic and convey ideas, concepts, and information through the selection, organization, and analysis of relevant content; and writing narratives to develop real or imagined experiences or events using effective technique, relevant descriptive details, and well-structured event sequences. This program will allow the Glassboro Public School District to directly impact the academic success of approximately 60 incoming seventh and eighth grade students.

This new program will be enhanced through on-site guest speakers who will provide real world writing topics and situations to build background for budding writers. Presenters will include a published author, a Glassboro Police Department representative, and a Rowan University Planetarium expert, to provide cross-curricular real world writing experiences.

- The WriteStart Boot Camp Program at the Glassboro Intermediate School will offer a 7 week summer camp. The camp will meet 3 days a week servicing the socioeconomically disadvantaged students of Glassboro Public School District. This institution will stimulate and develop deeper self-concepts, encourage exploration and learning, while providing academic content in writing that is aligned to the curriculum of the Glassboro Public Schools and 2010 Teaching and Learning Standards for 7th and 8th grades.
- This writing program will create a smooth transition and consistency when our students enter our rigorous middle school literacy programs in September 2015.
- Argumentative writing skills will include using words, phrases, and clauses to create
 cohesion and clarify the relationships among claims, reasons, and evidence. Students will
 learn to establish and maintain a formal style. Students will also learn to write a
 concluding statement or section that follows from and supports the argument presented.
- Students will also learn to write informative/explanatory texts by introducing a topic clearly, previewing what is to follow: organize ideas, concepts, and information, using strategies such as definition, classification, comparison/contrast and cause/effect.
 Students will develop the topic with relevant facts, definitions, concrete details,

- quotations, or other information and examples. Students will use appropriate transitions and precise language to inform about or explain the topic.
- They will also learn to engage the reader by establishing a context and point of view and introducing a narrator and/or characters; organize an event sequence that unfolds naturally and logically. Students will use narrative techniques such as dialogue, pacing and description, to develop experiences, events, characters, and provide a conclusion that follows from and reflects the narrators' experiences.
- We will provide two programs in the evening to parents designed to enhance their capability to impact their child's learning experience. Topics discussed will include utilizing PowerSchool to access student progress, promote community after school programs for students, and share in the writing experience.

HISTORY

It has been well documented that economic disadvantage and poor academic achievement are related. Students coming to school from economically disadvantaged and/or dysfunctional families and who may experience drug/alcohol problems and/or illiteracy at home are at a more severe disadvantage and arrive at school with many deficiencies when compared to other children.

One population of children that appears to be at a greater risk for learning difficulties are students living in subsidized public housing; i.e., developments like Ellis Manor. The problem is of such proportion and impact that, in 1989, President George H. Bush and our state governors identified this area as one of the six America 2000 Goals for Education. Specifically stated, the goal is that <u>every</u> child will start school ready to learn. Additionally, in 2001, the President George W. Bush made it a cornerstone of his administration with the No Child Left Behind Act.

In an effort to address this pervasive issue in Glassboro, we wish to initiate the WriteStart Boot Camp Program to give students who may be at a greater risk for learning difficulties a chance to become familiar both with their new learning environment, and also with the challenges in the writing curriculum that they will face in middle school.

PROBLEM

Our students who live in subsidized housing are at the highest risk for academic failure. We feel it is imperative that WriteStart Boot Camp will increase the academic and social success of all children entering 7th and 8th grades in September 2015, who are living in subsidized housing throughout Glassboro, NJ. WriteStart Boot Camp will help students in this socio-economic group retain more academic skills in literacy and writing, and will give them the tools to access community-based resources that are in place, in order to empower them to continue achieving academic success.

There are over 1,100 students receiving free and reduced lunches in the Glassboro Public School district. Most live in subsidized housing units in Glassboro, and those in middle school would be eligible for this new program. They are not all located in the lowest Census Tract areas of Glassboro, but the income levels of these residents well meet the low-income/below poverty standards set by the CDBG and the state.

Currently, there is no summer program for these students, which would help close the achievement gap for this at-risk Glassboro population. Approximately 90% of the town's below poverty level, low income children who are at a higher risk of academic failure live in subsidized housing in Glassboro, and would benefit our WriteStart Boot Camp Program and its services.

SOLUTION AND REASON FOR FUNDING

Using the CDBG funding, the WriteStart Boot Camp Program will create a community-oriented program which will last for seven weeks, from June 30 through August 13, 2015. It is an environment totally conducive to learning. All students will be transported to and from the program, which will be housed at Glassboro Intermediate School. Students will attend the program for 3 days a week, and will be fed both breakfast and lunch. New Jersey State certified teachers will provide instruction for 3 hours per day, 9 hours per week. This program will be a researched-based literacy and writing curriculum, using Common Core State Standards, and will be aligned to current middle school curriculum and instruction in Language Arts Literacy.

WriteStart Boot Camp program teachers feel that children entering 7th and 8th grades in 2015 who participate in this community-based program will have a huge head start on their 2015 / 2016 academic school year. Our nurturing environment will help to motivate them to attain higher levels of academic success. In this manner, they can learn and continue to develop into inquisitive, well-grounded adolescents who are confident and feel empowered to grow emotionally, physically, and cognitively.

Initially, we are piloting this program for the summer of 2015. However, our hopes are to expand this wonderful community and educational program into the following summers. The benefit is that all children in subsidized housing in Glassboro who are entering middle school in 2015 will now have the opportunity to be a part of WriteStart Boot Camp. This program will give our highest at-risk population a better chance to achieve academically in the future and change their perspective on education, the importance of learning, and the power of utilizing the resources available to them in our community of Glassboro. This program will also allow these students to experience a much easier transition into the secondary part of their education, which will begin in September 2015, at Glassboro Intermediate, and hopefully continue on for them at Glassboro High School.

PROGRAM OBJECTIVES

The purpose of WriteStart Boot Camp is to provide low income residents, living in subsidized housing throughout the Borough of Glassboro, New Jersey, with the tools necessary to understand and create effective narrative, informative, and argumentative writing. The parents / guardians will understand, appreciate and support the importance of writing in education for the present and for future endeavors.

The WriteStart Boot Camp Program meets the following National Objectives:

- A. Principally benefit low and moderate-income persons
 - a. 100% of the children participating in the WriteStart Boot Camp program live in public housing facilities and live at or below poverty level and are eligible for the free and reduced lunch program.
- B. Meet other urgent community needs.
 - a. Reduce number of African-American males eventually needing special education services.
 - Ninety percent of the students being served through the WriteStart Boot
 Camp program are either African American and or bi-racial.
 - b. Raise the academic achievement of low income populations.
 - i. It is the hope of the newly formatted program that we increase academic achievement of the low income students by 20%.

PROGRAM GOALS

The goal of the program is to build effective learners who are enthusiastic about reading and writing. Our goal is to help children become independent, self-confident, writers who have the ability to understand and create a variety of different writing pieces. Students in the program will become creative, independent thinkers who experience success while acquiring skills necessary to be an effective writer in the secondary curriculum and in their future careers. Students will learn in an environment that encourages them to take risks without judgment from their peers.

Additional goals include:

- A. To provide a safe and healthy learning experience for middle school students who are struggling with reading and writing.
- B. To build lifelong learners who recognize the value and importance of writing.
- C. To improve student writing in the secondary grades evidenced through the use of writing portfolios.
- D. To improve student ability on research-based writing assignments.

METHOD(S) USED TO MEASURE AND TRACK GOALS

Students will be evaluated on their writing and group activities using CCSS-aligned writing rubrics that are specific to narrative, informative, and argumentative tasks. Rubrics will evaluate the effectiveness of content, organization, grammar, spelling, and punctuation. Students will also be evaluated on their ability to work with others, participate in small group and whole group discussions, and their ability to complete short tasks relative to reading and writing.

In addition to the assessment system, teachers will monitor student writing, collect data, and maintain student portfolios and produce anecdotal records to assist and provide evidence that each individual student is making progress. Student progress will be monitored by teachers throughout the WriteStart Boot Camp program.

TARGET POPULATION

According to the New Jersey Department of Education, there are 554 school districts in New Jersey. Glassboro Public Schools are in the lowest 19th percentile regarding socioeconomic status. As a result, NJDOE has assigned us a DFG rating of B. The target population to be served consists of low income families with children entering middle school who reside in subsidized housing or other comparable Section 8 housing in throughout the Borough of Glassboro, and those who receive free or reduced lunches.


